The WBAF also hosts World Business Angel Investors Week, which is celebrated every year under a global theme.

The World Business Angels Investment Forum supports economic development of countries by (1) stimulating and supporting the establishment and growth of early-stage ventures, (2) easing access to finance for entrepreneurs, (3) assisting digital transformation of startup ventures and SMEs in 'the new normal', (4) accelerating the life cycle of early-stage companies by compressing years of learning by doing, (5) easing access to quality education, mentorship, coaching and consultancy for entrepreneurs, startups and SMEs, (6) introducing new markets for global entrepreneurs, (7) easing access to world-class investments for world-class startups and qualified investors, (8) supporting countries in creating national champions of their startup ecosystems, (9) increasing financial inclusion, and (10) contributing to job creation and economic development around the world.

It accomplishes its mission through the WBAF Financial Inclusion Center, the WBAF Business School, the WBAF Global Startup Investment Promotion Agency, and the WBAF Angel Investment Fund.
